Issue Spotlight: Prevailing Wage and Worker Protections

Prevailing wage laws ensure that taxpayer dollars are spent on high-quality public works and that workers are paid a livable wage. This month, House Bill 78 was introduced by two of my colleagues to make Ohio's prevailing wage law optional for large local government and university construction projects. Similar anti-prevailing wage bills have been introduced in prior General Assemblies, as have repeated right-to-work bills and proposals that do away with project labor agreements. These bills are often introduced under the guise of market freedom, but these anti-worker bills ultimately reduce wages, limit the power of employees to negotiate fair contracts, make working conditions less safe for employees and employers alike, and stall the efficiency of small businesses, limiting their ability to make long-term financial decisions amid regular proposed changes to employment law.

HB 78 is designed to reduce pay for skilled labor by eliminating prevailing wage requirements in Ohio. Prevailing wage legislation, which has been law in Ohio for 88 years, ensures that workers earn a fair wage. Laws like HB 78 would reduce the efficiency and safety of projects and cut worker pay, harming the public interest and workers alike.

It is important for our elected leaders to continue to defend the dignity of work in this state. I am heartened to see a bipartisan group of lawmakers, including Republican Speaker Larry Householder, agree that HB 78 takes Ohio in the wrong direction. It would hurt both the integrity of our public projects and the workers who construct them. I will continue to be a vocal advocate for Ohio's workers, and to push responsible public policy that continues to make Ohio a great place to work.
